DIRECTIVE

***Re: Installation of Satellite Ticket Printer at non-agency locations
Resolution No.67***

In order that travel agents may enjoy the benefits of advanced technology in their operations, the TIC Board resolves that **a member shall be allowed to install satellite ticket printers (STPs) on the premises of its corporate clients under the following conditions:**

1. The member shall be able to prove an annual ticket sales volume of not less than HK\$10,000,000 with the corporate client concerned. The sales volume shall be certified by the client's auditors and reviewed on an annual basis.
2. The corporate client shall give an undertaking that tickets issued by the STP on its premises must be strictly for staff use only (refer to Appendix I). The corporate client shall be liable to be prosecuted for carrying on the business of a travel agent without a licence shall the undertaking be breached. A staff list shall be submitted at the time of application.
3. IATA resolutions (Resolution 810) relating to the installation of STP shall be strictly adhered to.

Application forms are obtainable from the IATA BSP office. The completed application forms together with the supporting documents required shall be submitted to TIC for endorsement before being forwarded to the BSP office.

This directive will take effect on **1st September 1998**. Restriction on installation of ticket printers as stipulated in the directive issued on 13th May 1995 (ref:BOD38/12/95) shall be repealed.

Violation of this directive may result in withdrawal of the satellite ticket printer from the corporate client's premises and penalty to be imposed on the member according to article 11(3)(a) & (b) of the Articles of Association of TIC.
