**Seminars on Trade Descriptions (Amendment) Ordinance 2008**  
**and related subsidiary legislation**

The Hong Kong SAR Government has announced on 12 December 2008 that the Trade Descriptions (Amendment) Ordinance 2008, which was enacted on 18 June 2008, and its eight pieces of related subsidiary legislation will come into operation on 2 March 2009.

To prepare and assist our traders in the retail industry for compliance with the statutory requirements under the new legislation, we are going to conduct a series of briefing seminars in January and February 2009 at the Customs and Excise Service Senior Officers' Mess, 9/F Rumsey Street Carpark Building, Central, Hong Kong. Each seminar will accommodate 100 participants and will last for about 2 hours. Details of these seminars are shown in the **reply slip** attached.
