2012-2013年度「ERB人才企業嘉許計劃」

2012年9月1日起接受機構申請成為「人才企業」

「ERB人才企業嘉許計劃」由僱員再培訓局 (ERB) 於2009年12月推出，是香港首個全面評估機構在「人才培訓及發展」策略和工作完善程度的認證系統，並對在「人才培訓及發展」有卓越表現的機構嘉許為「人才企業」(MD)。計劃首三屆合共有187間(中小企佔27間)來自30個行業的機構獲頒授「人才企業」殊榮。

計劃歡迎本港公營及私營機構參加，申請機構將免費獲得專業評審及報告，有助機構持續改善其「人才培訓及發展」策略及工作。成功獲嘉許為「人才企業」(MD)的機構，更可在兩年嘉許期內，獲授權使用「人才企業」標誌，有助提升企業形象、員工歸屬感及吸引人才加盟，享用專為「人才企業」而設的延續活動，交流經驗。

“ERB Manpower Developer Award Scheme” for 2012-2013

Application commences from 1 September 2012

The Employees Retraining Board (ERB) launched the “ERB Manpower Developer Award Scheme” (the Scheme) in December 2009. It is the first award scheme to assess the level of maturity of manpower training and development strategies and practices of organisations in Hong Kong. Organisations which have demonstrated exemplary performance in manpower training and development will be accredited as Manpower Developer (MD). In the first three years of the Scheme, a total of 187 organisations (with 27 SMEs) straddling some 30 industries have been accredited as MDs.

All public and private organisations in Hong Kong are welcome to join the Scheme. Applicant organisations will be entitled to free professional assessment service and report, which will facilitate sustainable improvement on their manpower training and development strategies and practices. Qualified MDs not only are authorised to display the MD logo during the 2-year validation period, which will be conducive to corporate image, staff loyalty and attraction to talents, but also can participate in the follow-up activities for MDs to exchange practical experiences.

This year, application period of the Scheme will be from **1 September 2012 until 15 November 2012**. ERB will organise two briefing sessions on 21 September 2012 (Friday) at 2:30 p.m.(for non-SMEs) and 4:00 p.m. (for SMEs) at Room 1006, Hong Kong Productivity Council Building, 78 Tat Chee Avenue, Kowloon Tong to introduce the Scheme.
