## 填寫參選表格說明 - 基本及普通會員提名

### [香港旅遊業議會理事選舉]

#### Notes on Completion of Registration Form – Nomination by Ordinary and Affiliate Members (Directors' Election of the TIC)

1. 根據《議會組織章程細則》第 49 條和第 50(1)條，候選人必須：
  - i. 是基本會員的行政總裁或執行董事，並已向議會登記為該會員的負責人；
  - ii. 是旅遊界某一範疇的專才或專家，而其專門知識能對議會有所貢獻；及
  - iii. 當選後可完成整個兩年任期而不違反《議會組織章程細則》第 45(2)條訂明的八年期限。According to Articles 49 and 50(1) of the Articles of Association of the TIC, a candidate must:
  - i. be the chief executive or executive director of an Ordinary Member who is registered with TIC as the authorized person,
  - ii. be a specialist or an expert in a special area within the travel industry who can contribute his expertise to the benefit of TIC, and
  - iii. be able to serve the full term of two years upon his election without violating the 8-year time limit as stipulated in Article 45(2) of the Articles of Association of the TIC.
2. 候選人必須得到三十家基本會員及 / 或普通會員 (不包括候選人本人)提名與簽名支持。提名人均須按《議會組織章程細則》第 49 條向議會登記為有關會員的負責人。  
A nomination shall be subscribed by 30 Ordinary or Affiliate Members (other than the candidate himself) of TIC. A subscriber must be the authorized person of the Member registered with TIC pursuant to Article 49 of the Articles of Association of TIC.
3. 準候選人宜盡可能獲得最多三十五個提名人的簽名支持，那樣即使有提名表格不合規格而導致提名無效，無效的提名人也可由額外的提名人遞補。  
In order to avoid invalidation of the nomination due to any irregularities that may be found on the nomination forms, a prospective candidate is strongly advised to submit up to 35 subscribers. The extra names provided will be reserved for substituting any invalid subscribers.
4. 每個提名人須各自填寫一份獨立的「提名表格」，表格須由向議會登記的負責人簽署。提名人只可提名一個候選人。準候選人有責任提醒提名人只能填寫一份提名表格。  
Each subscriber shall complete a separate and individual Nomination Form duly signed by the authorized person registered with the TIC. A subscriber may not nominate more than one candidate. A prospective candidate has the responsibility to remind the subscriber that he can complete one nomination form only.
5. 準候選人須把參選表格，連同(i)履歷、(ii)提名人摘要及(iii)由提名人各自簽署的提名表格一併交回議會辦事處。遞交時間為提名期內（二零二零年八月三日至二零二零年九月二日）任何一天（公眾假期除外）的辦公時間（星期一至五上午九時至下午五時三十分；星期六上午九時至下午一時）。  
A prospective candidate should hand in the Registration Form together with (i) Resume; (ii) Summary of Subscribers; (iii) Nomination Forms individually signed by the subscribers to the TIC office within the nomination period (3 August 2020 to 2 September 2020) during office hours (Monday to Friday: from 9 am to 5:30 pm; Saturday: from 9 am to 1 pm) on any day other than a

general holiday.

6. 為加快查核程序，請準候選人盡早遞交支持其提名所需的文件。在提名期結束後，議會辦事處會查核所有收到的提名。若發現有任何錯漏，準候選人須在通知日期起計的五個工作天內更正有關問題。如未能在規定期限內把情況糾正，有關提名會視作無效。

In order to expedite the checking process, a prospective candidate is recommended to submit the required documents in support of his/her nomination as early as practicable. At the close of the nomination period, the Executive Office will check all the nominations received. If any irregularities are found, the prospective candidates concerned will be given 5 working days as from the date of notification to make rectifications. If rectifications are not completed within the specified period, the nomination will be considered invalid.
