## 測驗須知 Important Notes

## I. 簡介

所有由 2012 年 1 月 1 日起遞交「導遊證」申請的人士,必須在<u>每次續證前</u>完成「導遊持續專業進修計劃」(「進修計劃」)的要求,方可申請續證。於 2012 年 1 月 1 日前遞交「導遊證」申請的人士,則仍然適用於現有制度,即是在<u>完成首次續證後</u>才須開始進行「進修計劃」。

## II. 目的

「香港知識測驗」<sup>(計)</sup>是「導遊持續專業進修計劃」三部份的其中之一。專為準備續領「導遊證」的入境導遊而舉辦的測試,目的是透過定期考核,讓導遊對香港知識不時溫故知新。

註:導遊可<u>選擇</u>參加由議會<u>認可機構</u>開辦的「香港知識工作坊」,以代替測驗。認可機構名單可於議會網頁下載

## III. <u>測驗形式</u>

測驗以多項選擇題形式進行,共 40 條題目,限時為 1 小時 30 分。考生可選擇中文卷或英文卷。

## IV. 測驗範圍

內容取材自「香港知識測驗」溫習資料,有 關資料將於接納測驗申請後郵寄或電郵給 考生。

### I. Introduction

People submitting their application for the Tourist Guide Pass on or after 1 January 2012 are required to fulfil the requirements of the Continuing Professional Development Scheme for Tourist Guides (CPD Scheme) every time before applying for the Pass renewal. The current policy which requires the Pass holders to start the CPD Scheme after completing the first-time renewal of the Pass will still apply to those submitting their application for the Tourist Guide Pass before 1 January 2012.

## II. Objectives

'Knowledge on Hong Kong' Quiz <sup>(NB)</sup>, which is one of the three elements of the Continuing Professional Development Scheme for Tourist Guides, aims to help the tourist guides to consolidate and update their knowledge on Hong Kong. Tourist guides must pass this quiz before renewing their Pass.

NB: Tourist guides may <u>choose</u> to attend a 'Knowledge on Hong Kong' Workshop held by <u>organisations recognised by the TIC</u> in lieu of passing the Quiz. The list of recognised organisations can be downloaded from the TIC's website (https://www.tichk.org/en/guides/cpd).

Please contact the organisations concerned for details of the Workshop.

#### III. Format

The Quiz contains 40 multiple-choice questions. The duration is 1 hour 30 minutes. Candidates may choose the test paper in Chinese or English.

#### IV. Syllabus

All the questions are taken from the "Knowledge on Hong Kong Quiz - Revision Notes" which will be posted or e-mailed to the candidates once their applications are accepted.

## V. 分數

每份試卷共有 40 條題目,答對<u>至少 32 條題</u> 目方算合格。

## VI. 報考方法

- 1. 於<u>截止報考日期或之前將</u>填妥的表格及 費用(港幣一百元)郵寄或親身交回議會 行業培訓部。如以郵寄方式遞交申請 表,則以郵戳日期為準。
- 2. 費用可以現金或支票繳交(如選用郵寄方式,必須以劃線支票繳費),支票抬頭請註明「香港旅遊業議會」,並在背面寫上申請人姓名及導遊證編號。請勿郵寄現金。親臨議會遞交申請者可以現金繳付費用。
- 3. 使用劃線支票繳交費用的考生應確保銀 行戶口有足夠款項以支付費用,若因銀 行戶口存款不足而被銀行徵收行政費 用,議會一概不會負責。
- 4. 申請若被接納,議會會以<u>郵寄或電郵方</u> 式向考生派發《考生須知》及《香港知 識測驗溫習資料》供考生備試之用。<u>申</u> **請一經接納,費用恕不退還**。但如因工 作關係,考生必須於<u>測驗前最少三個工</u> 作天出示公司信或相關證明文件<u>正本</u>, 最多可申請延期測驗一次。
- 5. 申請若不被接納,或所報考時段經已額 滿或取消,議會將以平郵退還已繳之測 驗費用。
- 6. 若申請人於<u>測驗前兩星期</u>仍未收到《考生須知》及《香港知識測驗溫習資料》, 請致電 2807-1199 向議會行業培訓部職 員查詢。
- 7. 考生如更改通訊地址,必須儘早以書面 通知議會辦事處。
- 8. 議會保留修訂測驗細則的權利。如有修 訂,申請人/考生將獲通知。

## V. Scores

Each question paper contains 40 questions. Candidates must answer at least 32 questions correctly in order to pass the Quiz.

## VI. How to apply

- 1. Submit the completed form and quiz fee (HK\$100) to the TIC by post or in person on or before the deadline for application. For submission by post, the deadline is based on the stamp chop date.
- 2. Payment can be made by cash (for submission in person only) or crossed cheques payable to 'Travel Industry Council of Hong Kong' with applicant's name and Tourist Guide Pass number written on the back. Please do NOT mail cash. Cash is acceptable for submission of application in person.
- Applicants who make their payment by crossed cheques are advised to make sure that there are enough funds in their accounts. The TIC is not responsible for any administration fees incurred as a result of bounced cheques.
- 4. Once an application is accepted, the candidate will receive by post or e-mail a set of 'Important Notes to Candidates' and 'Knowledge on Hong Kong Quiz Revision Notes' for preparation for the Quiz. No refund will be made after the acceptance of application. However, request for postponement of the Quiz for business reason can be granted once while application with the original company letter must be submitted at least 3 working days before the quiz date for approval.
- 5. Should an application be rejected or the Quiz be full or cancelled, the fee (if paid) will be returned in the form of a cheque by post.
- Should an applicant not receive a set of 'Important Notes to Candidates' and 'Knowledge on Hong Kong Quiz - Revision Notes' for preparation for the Quiz <u>TWO WEEKS before the quiz</u>, please contact the TIC Industry Training Department on 2807-1199.
- 7. Candidates are required to immediately inform the TIC of any change in contact information.
- 8. The TIC reserves the right to amend any rules, regulations or details of the Quiz whenever necessary, and the applicants and candidates will be informed of the relevant amendments.

## VIII.惡劣天氣安排

- 2. 若天文臺發出三號熱帶氣旋或黃/紅色 暴雨警告信號,或於<u>測驗開始前的三小</u> 時前取消八號或以上熱帶氣旋或黑色暴 雨警告信號,測驗將如期舉行。

## IX. 個人資料收集說明

- 1. 課程報名表上所填報的個人資料,香港 旅遊業議會(下稱「議會」)將用作如下 用途:
  - (i) 處理測驗報考事官;
  - (ii) 儲存考生的資料於議會;
  - (iii) 向考生發放測驗成績及有關資料;
  - (iv) 進行研究或統計分析;及
  - (v) 其他相關用途。
- 2. 申請人請儘量提供足夠資料,否則議會 不能有效處理閣下的申請。
- 3. 議會會將申請人的資料保密,但可能會 將申請人的有關資料,提供給任何其他 人士,以作第1段所列舉的用途。
- 4. 根據《個人資料(私隱)條例》,申請人 有權:
  - (i) 查閱議會是否持有申請人的個人 資料;
  - (ii) 要求獲得 4(i)段所述資料的複本;

### VIII. Bad weather arrangements

- 1. If Tropical Cyclone No.8 or above, or Black Rainstorm Warning Signal is in force, the quiz will be cancelled. Candidates who are on the way to or already at the quiz venue should return home under safe conditions. If the signal is in force when the quiz is in session, the quiz will continue for the full time allotted.
- If Tropical Cyclone No.3 or Amber / Red Rainstorm Warning Signal is in force, or Tropical Cyclone No.8 or above, or Black Rainstorm Warning Signal is cancelled <u>3 hours</u> <u>before</u> a quiz begins, the quiz will be held as scheduled.

#### IX. Notes on collection of personal data

- 1. The personal data provided in this enrolment form will be used by the Travel Industry Council of Hong Kong (TIC) for the following purposes:
  - (i) to process guiz applications and enrolment;
  - (ii) to maintain candidates' records in the TIC;
  - (iii) to distribute quiz results and disseminate relevant information to candidates;
