# Important notes on the renewal of the Tour Escort Pass

## (I) When to apply

Pass holders may apply for renewal of their Pass <u>three months before it expires</u>. <u>No reminders</u> will be sent by the TIC for the renewal of the Pass in due course. The new Pass will be valid for three years, counting from the day following the day on which the old Pass expires.

# (II) Renewal after expiry

- Holders of the Tour Escort Pass will be <u>exempted from taking the Certificate Examination</u> if they renew their Pass <u>within two</u> <u>years after the expiry of the Pass</u>. The new Pass will be valid for three years, counting from the day following the expiry day of the old Pass.
- Pass holders who renew their Pass more than two years after expiry of the Pass will have to pass the Certificate Examination in order to obtain a new Pass. Candidates who fail the examination may take a resit, and the number of attempts allowed is not limited. The new Pass will be valid for three years, counting from the day on which the Pass is issued.

## (IV) How to apply

- 1. Return the completed "Application Form for the Renewal of the Tour Escort Pass" and "Declaration" (Attachment I) together with the following documents to the TIC by post or in person:
  - (i) One recent colour photo with the following specifications:
    - a. 1.5" x 2" (4 cm x 5 cm)
    - b. Make sure photo presents full head from top of hair to shoulders, and include a full face, front view and open eyes
    - c. Plain white background
    - d. Photos should not include sunglasses or hats
    - e. Applicant's full name and Tour Escort Pass Number should be written on the back of the photo.
  - (ii) A crossed cheque amounted HK\$150 payable to "Travel Industry Council of Hong Kong"; <u>or copy</u> of bank-in slip (<u>Please deposit cash only</u>) / transaction record (Bank of China (HK) Ltd: A/C no.: 031-349-1-038340-4). Cash will be accepted for submission of application in person only. <u>Please do NOT mail cash</u>.
- 2. Acknowledgement of receipt will be sent by SMS or e-mail upon the receipt of an application submitted by post. For applicants who do not receive any message of acknowledgement within 7 working days since the date of posting, please contact the TIC Industry Training Department on 2807-1199.
- Eligible applicants will be issued the renewed Pass within 4 to 5 weeks from the date of submission of application. Pass holders will be notified by <u>SMS or e-mail</u> when the renewed Pass is ready for collection. Applicants who do not receive any notification for the collection of Pass in due course may contact the TIC Industry Training Department on 2807-1199.
- 4. Eligible applicants in urgent need may request an 'Acknowledgement of Application for the Renewal of the Tour Escort Pass', a document that provisionally allows its holder to undertake the duties of a tour escort. The document can be immediately available for eligible applicants making their submissions in person. Applicants who submit their application by post must enclose a self-addressed stamped envelope specifying 'Acknowledgement of Application for the Renewal of the Tour Escort Pass' on the front.

## (V) Renewal applications that require special deliberation

In any of the following situations, a Tour Escort Pass renewal application will be deemed to be in need of special deliberation and will be referred to the Tourist Guide and Tour Escort Deliberation Committee for deliberation:

- 1. the applicant provides factually untrue information or is suspected of making any false statement;
- 2. the applicant declares that he/she has been convicted of a criminal offence the applicant declares that he/she has been convicted in Hong Kong or elsewhere of an offence which involved narcotics or drugs, sex or violence, or seriously improper conduct or dishonesty (including but not in any way limited to: unlawfully undertaking any business without proper authorisation or permission; smuggling; theft; forgery; fraud; deceit; burglary; handling stolen goods, bribery or corruption);
- 3. the applicant fails to declare that he/she has been convicted in Hong Kong or elsewhere of an offence listed above;
- 4. the applicant's Tour Escort Pass or Tourist Guide Pass has been revoked, or the applicant's application for Pass renewal has been rejected;
- 5. the applicant's Tour Escort Pass or Tourist Guide Pass has been revoked and he/she has failed to return the Pass to the TIC within the required time limit of seven days;
- 6. the applicant has worked as a tour escort without a Tour Escort Pass or with an invalid Tour Escort Pass; or the applicant has worked as a tourist guide without a Tourist Guide Pass or with an invalid Tourist Guide Pass; or
- 7. the applicant has violated the Code of Conduct for Outbound Tour Escort while holding an invalid Tour Escort Pass and the Compliance Committee has imposed a penalty; or the applicant has violated the Code of Conduct for Tourist Guides while holding an invalid Tourist Guide Pass and the Tourist Guide and Tour Escort Deliberation Committee has imposed a penalty.

- Applicants will be required to produce their HKID Card in person for verification purposes, and staff of the TIC will only sign the 3. application form after verifying the contents of the applicant's HKID Card. If an applicant is unable to come to the TIC in person, the applicant may submit a copy of his/her HKID Card by post or by fax but any such copy shall be retained until such time as the applicant concerned is able to produce his/her HKID Card in person for verification purposes. The TIC reserves the right to require the production and to make and retain copies of an applicant's HKID Card in any circumstances which are permitted by law.
- The TIC will keep the personal data of applicants confidential but may provide such data to any other person or his/her representative 4. for any one or more of the purposes set out in paragraph 1 above.
- 5. According to the Personal Data (Privacy) Ordinance, applicants have the right to:
  - ascertain whether their personal data are held by the TIC; (i)
  - obtain a copy of the data mentioned in paragraph 5(i); and (ii)

# 領隊證持有人注意事項

# Points to note for holders of the Tour Escort Pass

#### I. 領隊證的發證條款 Conditions for issuance of the Tour Escort Pass

1. 領隊證由香港旅遊業議會發出,並受議會現行及不時修訂的相關規例所約束,持證人須經常瀏覽議會網 頁查閱最新消息。

The Tour Escort Pass is issued by the Travel Industry Council of Hong Kong (TIC) and subject to the relevant regulations of the TIC as currently in force and as amended from time to time. Pass holders are required to read about the latest news at the TIC's website regularly.

2. 領隊證乃香港旅遊業議會所有,不得轉借他人或作其他非指定的用途。議會有權撤銷、終止或收回該證。

The Tour Escort Pass is the property of the TIC. It is not transferable and must not be used for purposes other than those specified. The TIC reserves the right to revoke, terminate or withdraw the Pass.

The names (Chinese and English) of Pass holders, their Pass numbers and the expiry dates of their Passes will be included in the Outbound Tour Escort Directory, which is displayed on the TIC's website and may be accessed by travel agents and members of the public.

Pass holders must observe the codes and directives concerning tour escorts issued by the TIC. Non-compliance with the codes and directives will be subject to disciplinary procedures, and the information on suspensions or revocations of Tour Escort Passes will be posted on the TIC's website for different durations in accordance with relevant guidelines, which may be accessed by travel agents and members of the public.

Otherwise, their Pass may be suspended or revoked.

Pass holders who renew their Pass <u>more than two years after expiry of the Pass</u> will <u>have to pass</u> <u>the Certificate Examination for Outbound Tour Escorts</u> in order to obtain a new Pass. Candidates who fail the Examination may take a resit, and the number of attempts allowed is not limited. The new Pass will be valid for three years, counting from the day on which the Pass is issued.
