Thank you for your fax of April 1, 2015, Consul General Hart, concerning passport validity requirement for travelers traveling to the United States. We have been asked to respond to your fax.

When traveling to the United States, travelers are required to carry a passport valid for at least six months beyond the intended stay in the United States. Under country-specific agreements, certain travelers may travel to the United States using a passport with less than six months' validity.

A list of countries whose citizens may apply for a visa or travel to the United States using a passport with less than six month validity can be found on the Department of State's website at <a href="http://www.state.gov/documents/organization/104770.pdf">http://www.state.gov/documents/organization/104770.pdf</a>.

Please note that the length of stay in the United States will not be granted beyond the actual expiration date on your passport.
