# Notes on Completion of Registration Form - Nomination by Association Members [Directors' Election of the TIC]

- 1. 根據《議會組織章程細則》第49條和第50(1)條,候選人必須:
  - i. 是基本會員的行政總裁或執行董事,並已向議會登記為該會員的負責人;
  - ii. 是旅遊界某一範疇的專才或專家,而其專門知識能對議會有所貢獻;及
  - iii. 當選後可完成整個兩年任期而不違反《議會組織章程細則》第 45(2)條訂明的八年期限。

According to Articles 49 and 50(1) of the Articles of Association of the TIC, a candidate must:

- i. be the chief executive or executive director of an Ordinary Member who is registered with TIC as the authorized person,
- ii. be a specialist or an expert in a special area within the travel industry who can contribute his expertise to the benefit of TIC, and
- iii. be able to serve the full term of two years upon his election without violating the 8-year time limit as stipulated in Article 45(2) of the Articles of Association of the TIC.
