Terms of reference

職責

- To set out details of the Pilot Information Technology Development Matching Fund Scheme for Travel Agents (the Pilot Scheme), including the criteria and procedures for application, the assessment criteria, and the terms and conditions and details of the subsidy.
制定「旅行社資訊科技發展配對基金先導計劃」的詳情，包括申請資格、申請程序、評審準則、資助條款及細則等。
- To set up an assessment committee and decide its terms of reference and composition.
負責成立評審委員會，包括擬定其職責及組成。
- To deliberate legal matters related to the Pilot Scheme, including vetting the legal documents which need to be signed by the TIC, and the advice and suggestions provided by the TIC's lawyers.
審議與先導計劃有關的法律事宜，包括審核議會需要簽署的各種法律文件，以及議會律師提供的相關意見和建議。
- To promote active participation in the Pilot Scheme by the industry.
推動業界積極參與先導計劃。
- To monitor the implementation of the Pilot Scheme, and to assess its efficacy.
監察先導計劃的推行，並評估其效益。
- To monitor the use of funding in relation to the Pilot Scheme c adhere to the principle of financial prudence.
監察先導計劃款項的運用，確保遵守審慎理財原則。
- To vet various reports on the Pilot Scheme to be submitted by the TIC to the authorities.

- The convenor of the working group shall be a Director of the TIC. Its members shall include seven representatives from TIC - Convenors of the Inbound, Mainland China Inbound Tour Affairs, Outbound, Member and Public Relations, Staff and Finance, Ticketing and Training Committees, one representative from non-trade, one representative from Tourism Commission and one IT experts.
