## INFORMATION ON MEMBERSHIP APPLICATION

# A. Membership Criteria

There are two kinds of TIC member agent. The principal criteria for the two kinds of membership are:

#### **ORDINARY MEMBER**

- 1. it is a limited company incorporated or registered in Hong Kong;
- 2. its only business is travel-related and tourism;
- 3. it is a member of one of the Association Members [Note 1];
- 4. it has a minimum paid-up capital of HK\$500,000.- plus HK\$250,000.- for each additional branch office;
- 5. its controllers, directors, principal shareholders, secretary or officers or any person employed or concerned in the management of its travel-related and tourism business and each of them are respectable and honest businessmen and are otherwise Fit and Proper Persons.

#### **AFFILIATE MEMBER**

- 1. he is a sole proprietorship or partnership;
- 2. he is a member of one of the Association Members [Note 1];
- 3. he and his partners or any person employed or concerned in the management of his travel-related and tourism business and each of them are respectable and honest businessmen and are otherwise Fit and Proper Persons;
- 4. he shall **not** 
  - 1. have any branch office; and
  - 2. organise or operate a tour (he may sell outbound package tours, book air tickets, etc).

## B. Fees

#### 1. Entrance Fee

Ordinary member: HK\$3,000.-Affiliate member: HK\$1,800.-

### 2. Annual Subscription

Ordinary member: HK\$1,000.-&

HK\$100.- per branch

Affiliate member: HK\$600.-

\* Applicants who are admitted as members between 1st January and 30th June shall pay the half-yearly rate of HK\$500.- (for Ordinary Member) and HK\$300.- (for Affiliate Member) in the first year.

- 2. Business Registration Certificate (copy)
- 3. Certificate of Incorporation (copy) for Limited Company only
- 4. Articles of Association (copy) for Limited Company only
- 5. Return of Allotments [FORM NSC1] or Annual Return [FORM NAR1] submitted to the Companies Registry (copy) and/or Letter issued by the Auditor/Solicitor to certify the paid-up capital and shareholding structure of the company for Limited Company only
- 6. Incorporation Form [FORM NNC1] and/or Notification of Change of Director [FORM ND2A] reporting the latest information of directors of the company (copy) for Limited Company only
- 7. Business Registration Certificate Application Form [FORM 1(a) or FORM 1(c)] (copy) for Sole Proprietorship/Partnership
- 8. Declaration made by the company and each shareholder/director/authorised person/manager (i.e. completion of enclosed FORM D (i) and FORM D (ii))
- 9. Document appointing the authorised person who must be the Chief Executive or Executive Director of the company:
  - a. Board Resolution/enclosed **FORM** C for Limited Company;
  - b. Authorisation Letter/enclosed **FORM C** (i) for Sole Proprietorship/Partnership
- 10. Travel Agent Licence and Business Permit (if applicable) issued by the Travel Industry Authority (copy)

\* Note: Apart from the documents mentioned above, the TIC may request the applicant to provide other supplementary information or documents. Application will not be accepted if documents are not submitted in full.
